## What is the Nov. 5 Referendum?

The Nov. 5 referendum question will ask voters to amend the City Charter to allow City Commission to issue debt without prior voter approval for the following:

To respond to a declared emergency or disaster. For safety or public health projects, up to \$15 million per project. The proposed charter change applies to revenue bonds (to be paid from identified revenue streams) and not general obligation bonds that are paid with property taxes.
